Approval of Minutes from Previous Meeting:

Old Business:

A.) Trustee Report:

Annette Hubick shared her report as follows:

New K-4 Curriculum

The latest draft K-4 curriculum was announced and is available to view online at new.learnalberta.ca.

French Immersion Programming

- Last fall, the board began the process of looking at ways to strengthen the French Immersion Program. Step one was to survey parents of FI students, which provided valuable feedback.
- Following a thorough assessment of all aspects of the program, a decision has been made to continue offering French Immersion in schools where it's currently housed.
- Note: it will likely be a 2-3 year time frame to work through all elements in strengthening French Immersion program. We are only sharing the pieces that have been determined and there will be multiple updates, such as this one, during that course of time. Some of these decisions will be made by the Board and some will be made by the Superintendent. Further engagement may be required as the Board and senior administration work through every element of this review.

Cannabis legalization – October 17

As many of you have already seen, the division sent an email in anticipation of the legalization of Cannabis on October 17th to remind EIPS students and families that the same restrictions in place for tobacco and alcohol use apply to the consumption of cannabis products, meaning **cannabis in any form can't be sold, served or consumed in Division facilities, including schools or on buses.**

2018/19 Enrollment

EIPS serves 17,170 students, which is 23 more than budgeted (meaning it was prudently estimated).

EIPS board meeting

At the next public board meeting, the board will receive the unaudited financial report for the 2017-18 school year. A reminder that the board's meeting package, including these reports, are available on the EIPS website. Highlights are:

• The Division ended the fiscal year with a deficit of \$3.06 million. In June, EIPS projected a \$3.23 million deficit. The resulting favorable variance of \$0.17 million equates to 0.08% of the overall budget.

- This deficit decreases the Accumulated Surplus to \$20.62 million. The accumulated surplus includes:
 - o investment in Board-funded tangible capital assets (\$5.35 million)
 - Capital reserves (\$1.35 million).
 - o operating reserves (\$13.92 million)
 - \$3.96 million are designated for use by schools (they are allowed to carry forward a maximum of 2% of their annual budget to future years)
 - \$4.04 million Division Allocated Reserves have a balance of; these reserves will be used to fund specific expenses as identified by the Board (e.g., mechanical cooling units, Off to a Good Start program for new to EIPS teachers, costs of the new schools not covered by the Government)
 - Leaving us with \$5.92 million in unallocated reserves (2.96% of the budget) to cover emergent issues, price fluctuations and stabilize funding in the future.

B.) Principal's Report:

Cathy Allen shared the following highlights:

GOAL 2 - Staff use evidence-based practices to enhance student learning.

GOAL 3 - Students are equipped to make informed decisions regarding their advancement through high school and beyond.

- We had a visual review of the school budget and we were able to ask detailed questions. If you ever want to look at or ask questions you are free to call Cathy Allen.
- Many clubs and activities are well under way please watch website for highlights through the weekly Sabre Scene
- Cannabis becomes legal on Wednesday. It will follow basically the same policy as alcohol, it is not permitted on school grounds no matter what age you are. Do not come to school high. The school is looking at good neighbor strategies to implement to maintain good relations.
- November break is the 12th to 16th
- There is a new policy that all exam rewrites will be after school on Tuesday and Thursdays. These will be monitored by EA's.
- Awards ceremonies for last year are upcoming this week for grade 10 and 11, Grade 12's will be on Nov 8th

C.) COSC Report:

Following the Mix & Mingle, we had our first meeting and chose an executive:


Chair – Jacquie Surgenor (Westboro, Sherwood Heights, Sal Comp)
